THE INFLATION REDUCTION ACT: WHAT INCENTIVES DO YOU QUALIFY FOR?

Consumer incentives you may qualify for:



Electric Vehicle Tax Credit Program

- \$7,500 nonrefundable tax credit for new EVs until 2032
- Up to a \$4,000 tax credit for used EVs from 2023* to 2032**
- Transferable tax credit to dealerships starting in 2024*
 - This lowers the upfront cost of purchasing an EV
- EV price limits (total cost cannot exceed the below amount)
 - Sedans up to \$55,000
 - SUV, truck, or van up to \$80,000
 - Used cars up to \$25,000
- Income Limits

New cars

- Single taxpayers \$150,000
- Heads of household \$225,000
- Joint filers \$300,000

Used cars

- Single taxpayers \$75,000
- Heads of household \$112,500
- Joint filers \$150,000



Clean Energy Tax Credit

- 30% of the total cost: complete system, installation, and additional fees
- Solar, wind, or geothermal systems qualify
- · No price cap
- Date: Projects completed from January 1st 2022 to 2032



Home Efficiency Improvement Tax Credit

- Up to \$1,200 per year for insulation and window improvements**
- Up to \$2,000 per year for appliances including AC units, boilers, and heaters**
- \$150 for home energy audits
- Date: Completed projects from January 1st 2023 to 2032
- Homeowners, renters, and muti-family homes qualify



Rebate Programs for Home Efficiency Improvements

- State energy offices manage these rebate programs
- States manage these rebate programs
- Improvements must lower household energy use
- Date: 2023* to 2031
- HOMES Rebate Program
- High-Efficiency Electric Home Rebate Act
 - Only low- and middle-income households will qualify
- Cannot be combined
